**Date: OCTOBER 4, 2021**

The Philippine Stock Exchange, Inc. ("PSE" or the "Exchange") received a report of an individual representing herself as a member of a project team established by PSE for "blockchain digital currency" soliciting investments and inviting people to create an account through their website. The said individual guarantees returns of 20 percent to 30 percent or USD1,000.00 to USD2,000.00 daily.

Attached are screenshots relating to the investment solicitation.

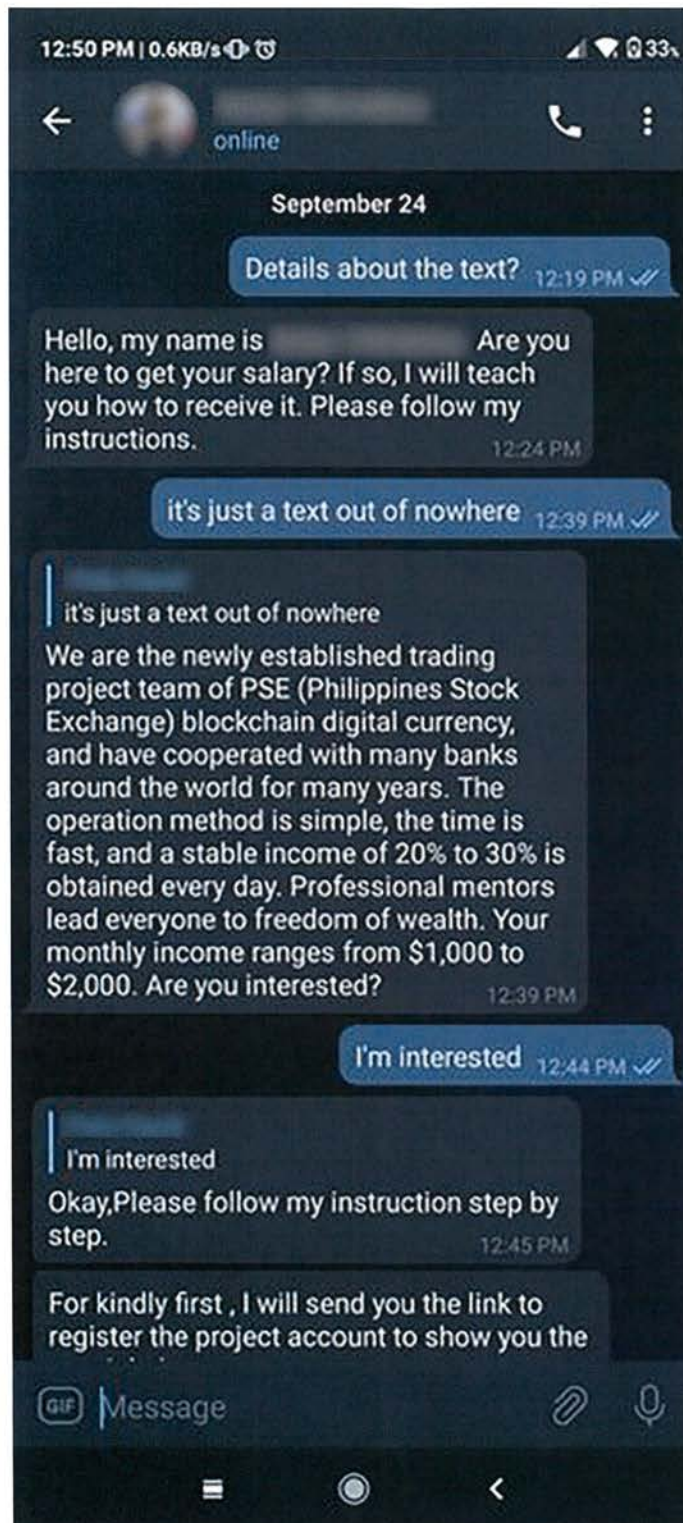
The PSE reiterates that it does not sell cryptocurrencies and that its employees or agents do not promote, for purposes of investment, any specific stock, investment instrument or cryptocurrency.

The PSE reminds the investing public to exercise prudence and due diligence in dealing with social media accounts that purportedly offer investments and represent themselves as employees or agents of the Exchange.

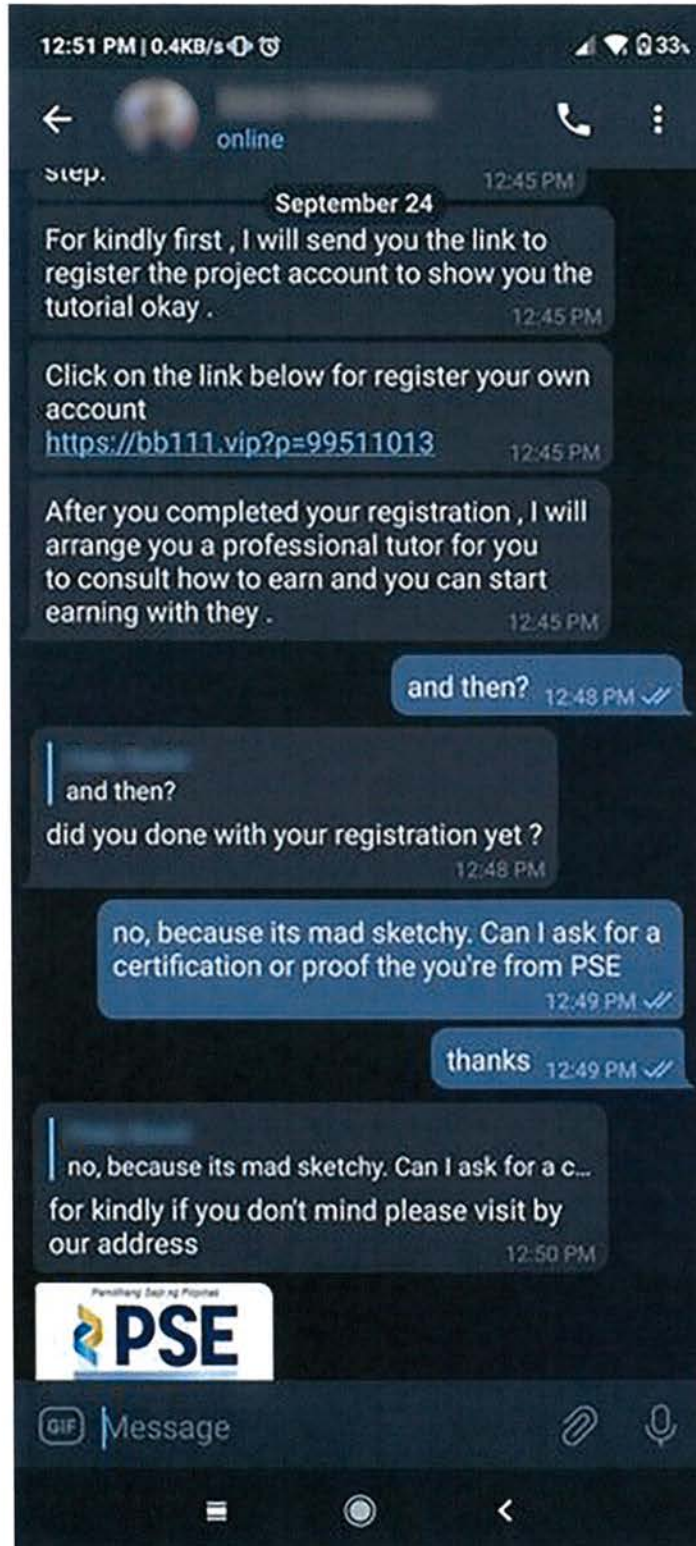

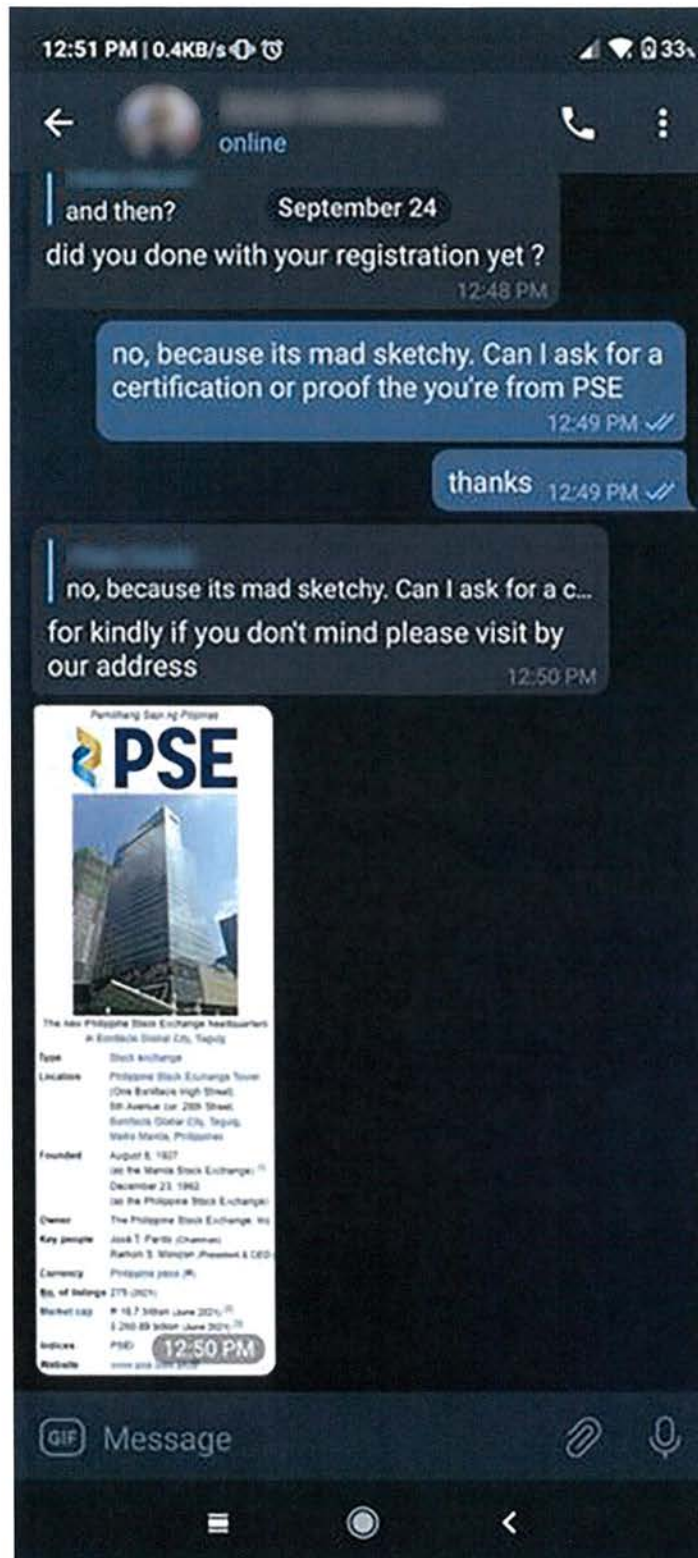

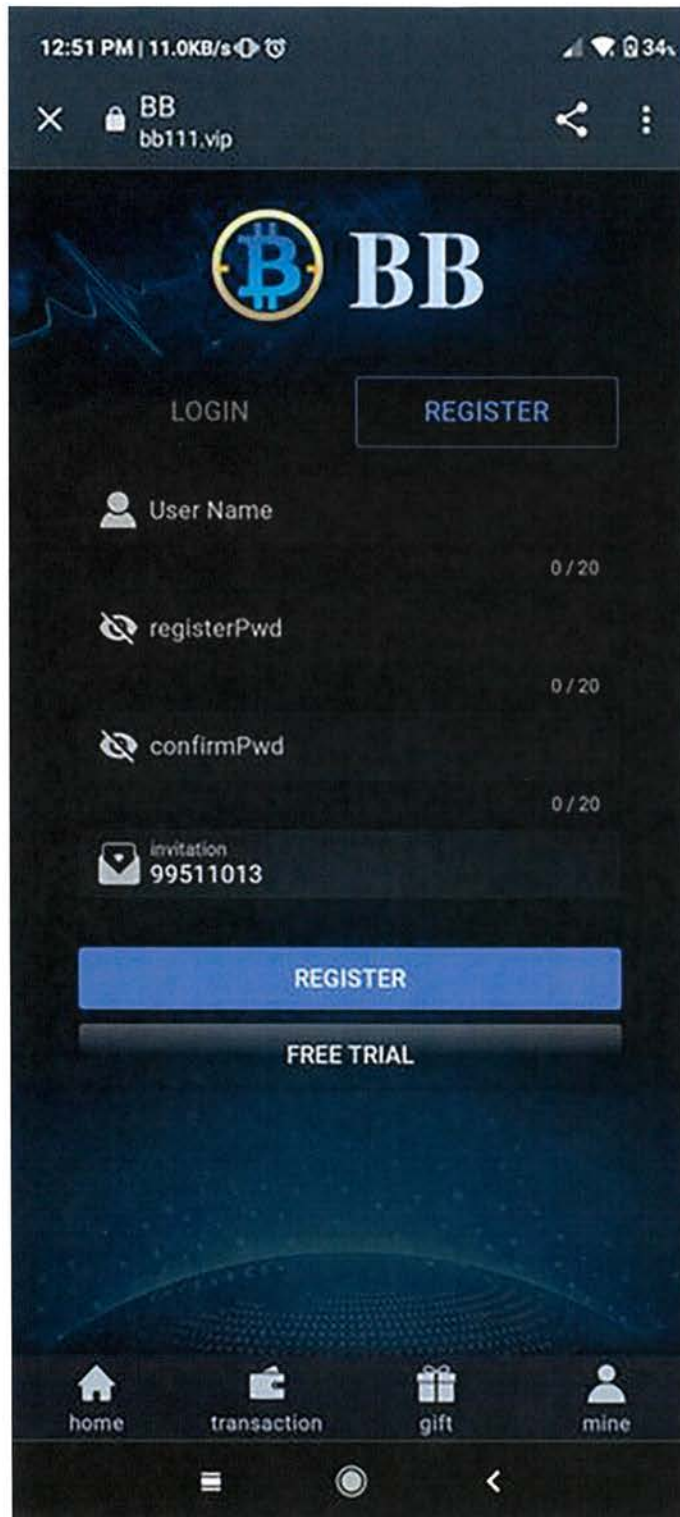
