The PSE publishes the list of Shari'ah-compliant securities in its website on a quarterly basis. The Exchange engaged the services of IdealRatings, Inc. to screen listed companies in accordance with the standards for Shari'ah compliance as stipulated by the Accounting and Auditing Organization for Islamic Finance Institutions. IdealRatings, Inc. is a provider of Islamic finance information that specializes in screening securities for Shari'ah compliance.

The criteria to become a qualified listed company are stated in the PSE Guidelines on Screening of Securities for Shari'ah Compliance, a copy of which may be downloaded at the PSE website under Trading > Products & Services > Shariah > Downloads.
