TERMS AND CONDITIONS

1. The data and contents found in the Index Subscription Bundle (“Index Bundle”), including all intellectual property rights over the same, are the exclusive property of The Philippine Stock Exchange, Inc. (PSE).
2. Subscription fee shall be included in the trading participant’s invoice issued by PSE.
3. PSE reserves the right to amend its subscription fees upon thirty (30) day prior written notice to existing Subscribers.
4. Coverage periods of less than a year shall be pro-rated based on 360 days. Coverage periods spanning several years shall be billed every calendar year. If Subscriber specifies “Indefinite” in the “To” column of the Coverage Period, or leaves the same blank, PSE construes this to be subscription on an on-going basis. In such case, the Subscriber may terminate its subscription by notifying the Head of PSE Market Data Business Department in writing of its intention to terminate the subscription at least thirty (30) days prior to preferred date to end the subscription.
5. The Index Bundle is strictly for personal or internal business use only. Subscribers, including its subsidiaries or affiliates, are not permitted to transmit, distribute, re-distribute or disseminate the Index Bundle and/or its contents in any format, or any data derived therefrom to third parties including distribution through display of the Index Bundle in web pages without the benefit of an access control mechanism approved in writing by the PSE after inspection thereof.
6. PSE reserves the right, at its discretion, and whether for cause or without, to modify Index Bundle, in whole or in part, or to discontinue the product / service altogether, upon written notice to the Subscriber. Subscribers who are notified that they are no longer allowed to receive Index Bundle shall be given a refund corresponding to the unused portion of the subscription already paid for the year.
7. The PSE shall not be liable to the Subscriber for any indirect, special or consequential loss or damage including without limitation loss of profit, business revenue, goodwill or loss, corruption of or error in data resulting from use or reliance on the Index Bundle.
8. PSE makes no representation and gives no warranty that the contents of the Index Bundle are complete, or error-free, or fit for a specific purpose.

If the issue remains unresolved it shall be submitted for arbitration at the Philippine Dispute Resolution Center, Inc. in Metro Manila, Philippines. Costs of arbitration shall be determined by the arbitrator.
