TERMS AND CONDITIONS

1. The data and contents found in the Subscribed Files (as described in page 1), including all intellectual property rights over the same, are the exclusive property of The Philippine Stock Exchange, Inc. (PSE).
2. For trading participants, subscription fee shall be included in the trading participant's invoice issued by PSE. For individuals or general public, a payment link shall be sent.
3. PSE reserves the right to amend its subscription fees upon thirty (30) day prior written notice to existing Subscribers.
4. Coverage periods spanning several years shall be billed every calendar year. If the Subscriber specifies "Indefinite" in the "To" column of the Coverage Period, or leaves the same blank, PSE construes this to be subscription on an on-going basis. In such case, the Subscriber may terminate its subscription by notifying the Head of Market Data Department in writing of its intention to terminate the subscription at least thirty (30) days prior to preferred date to end the subscription.
5. The Subscribed Files are strictly for personal or internal business use only. Subscribers, including its subsidiaries or affiliates, are not permitted to transmit, distribute, re-distribute or disseminate the Subscribed Files and/or its contents in any format, or any data derived therefrom, to third parties, including distribution through display of the Subscribed Files in web pages without the benefit of an access control mechanism approved in writing by the PSE after inspection thereof.
6. PSE reserves the right, at its discretion, and whether for cause or without, to modify the Subscribed Files, in whole or in part, or to discontinue the product / service altogether, upon written notice to the Subscriber.
